WILSON FILES FOR TEXAS SENATE DISTRICT 7 PROMISES TO SERVE “FULL TERM OF OFFICE” IF ELECTED

Spring, TX (December 3, 2013) – James Wilson, a local insurance agent and former Regional Director for US Senator Phil Gramm, made his campaign official today by filing for a place on the ballot for Texas State Senator in Senate District 7. Mr. Wilson will be seeking the Republican Party nomination, and made the following statement,
